- No work shall begin without a 24- hour notification to the Coweta County Public Works Department at (770) 683-ROAD (7623) by the Company or their subcontractor. If more than one road is included in this request, a work schedule depicting which roads will be worked on and on what days, will be provided at the time of notification. A copy of this form shall be made available on-site by the Company for inspection by county staff. FAILURE TO PROVIDE THIS INFORMATION WILL CAUSE A CITATION TO BE ISSUED!
- If [insert company] determines that it is necessary to perform work outside of the public right-of-way on private property, [insert company] shall make contact with the private property owner prior to performing any activities on private property. If [insert company] is unable to contact the property owner, Coweta County's ROW & Utilities Coordinator shall be notified to determine an appropriate course of action prior to any work commencing on private property.
