ELECTIONS	The Secretary of State Office requested that we have a Risk Limiting Audit for the December 6, 2022, Runoff. This audit was not required but our office held one on Wednesday, December 14 th . The audit went well, and our numbers matched. The Board of Elections and Voter Registration set their meeting dates for 2023. The Board voted to move the meetings to Wednesday at 10am. The following dates were set, and they are as follows: February 8 th , March 8 th , April 12 th , May 10 th , June 14 th , July 12 th , August 9 th , September 13 th , October 11 th , Monday-November 13th , December 13 th and January 10 th , 2024. Motion: Wayne Farmer Second: Randy Wahoske; Approved. Staff was originally planning to move into the new building in February. This has been delayed due to some site work that still needs to be completed. Staff now expects to move in April. Board Member Wayne Farmer would like for the Office to purchase 2 equipment trucks for delivery. The Board received a letter from Coweta County Administration Office, notifying that Tax Commissioner Robi Brook had retired on December 31, 2022, and requesting that a Special Election be held to fill the unexpired term. Deputy Tax Commissioner Justin McMichael will fill her position until an election can be held. The Board voted to call for the election which will be held November 7, 2023.
