ELECTIONS	Public Hearing regarding the relocation of the Advanced Voting Location at 22 East Broad Street Newnan, GA 30263 – No one attended hearing or called about the move. Board voted to proceed with the move if staff received no comments before the comment deadline of March 11th, 2023.  Relocation of the Senola Precinct – The City of Senola will be selling the Senola Senior Center at 300 Howard Rd; therefore, we will no longer be able to use this building as a voting precinct. We are proposing to move the precinct to the Leroy H. Johnson Community Center at 6652 E. Highway 16, Senola, Ga 30276. The community center is currently under construction. If the new center is not complete by the November 2023 election, then the county will bring in trailers to conduct the election. The board voted to proceed with moving the Senola precinct and set the public hearing for April 12th, 2023, at 10:00am.  AIP Process Update – The State of Georgia is going to require counties to use the poll pad for Absentee in Person voting. Check-in will be similar to election day, but you can print a voter's certificate or application for an absentee ballot.
