4. 2024 Election Dates

Director Gay advised that the Secretary of State's office had provided a list of the Election Dates for 2024. The dates have been sent to the precincts and Poll Managers. The Presidential Preference Primary is March 12, 2024, the General Primary Non-Partisan Election will be May 21, 2024. If there is a Runoff for this election, it will be June 18th, 2024. The General Election will be November 5, 2024. If a Runoff is needed for this election, it will be December 3, 2024.

5. Update on Request to Modify Sign Ordinance.

Director Gay advised staff met with Administration about Member Scoggins's request to modify the sign ordinance about campaign signs on county property. At this time there are no plans to modify the sign ordinance, but signage will be placed at this location to indicate the 150 foot no campaign zone. No action required.

6. Update on Community Center near Fischer Road/Canongate Precincts

Director Gay advised that she was scheduled to have a meeting with Administration yesterday (6/13/2024) to receive a timeline on when the building would be complete, but the meeting was canceled. She is expecting to have an update by Administration before the next Board meeting in July. Staff did meet with Mike Johnson, Director of Public Facilities, he advised that the Fischer/Canongate Community Center project is further along than the Senoia Community Center. She advised that the building has started to go up. No action required.
