# 6. Set Early Voting Dates and Times for 2023

Director Gay stated that the BOER needs to set the Early Voting dates and times for the November 7, 2023, Election. She stated that state law requires that Early Voting be held from 9:00am-5:00pm, Monday through Friday from Monday, October 16, 2023, through Friday, November 3, 2023, and at least two Saturdays, which would be October 21, 2023, and October 28, 2023 from 9:00am-5:00pm. Chairman Reeves asks if there were any questions. Director Gay asked if board members would like to add any additional days or times to the Early Voting schedule. The board agreed that the dates and times were acceptable as presented.

# 7. Update on Community Center near Fischer Road/Canongate Precincts

She proposed that the BOER combine the #7 Fischer Road Precinct located at 3370 Fischer Road, Newnan, GA 30265, and the #23 Canongate Precinct located at 200 Pete Road, Sharpsburg, GA 30277 and move them to the new Canongate Community Center located at 30 Pete Road, Sharpsburg, Ga 30277. Director Gay stated that she is prepared to run the required advertisements on Saturday, July 15, 2023, and proposed that the BOER set a public hearing date for Wednesday, August 16, 2023, at 10:00 am.
