Director Gay advised the Elections and Voter Registration Office has received a resolution from the Town of Turin calling for a Special Election to be held November 7, 2023 to present a question to the voters of the Town of Turin regarding Sunday Sales of alcoholic beverages by the drink. She then read the resolution and asked the Board to adopt the resolution and to give her the authority to call for the election. The office will submit the call for the election to the newspaper.
