4. Update on Logic and Accuracy Testing for March 12, 2024

Director Gay advised that Logic and Accuracy testing has been completed for the equipment that will be used for AIP and Election Day. She also advised that testing still needed to be completed on the Central Scanner, and that this should be completed this week.

5. Absentee Updates and Reminders for March 12, 2024, PPP

Director Gay advised that Monday, February 12, 2024, was the first day the office was allowed to mail Absentee Ballots. As of yesterday 253 ballots have been issued and 1 ballot was been returned and accepted.

AIP Voting will begin Monday, February 19th, 2024, at 9:00 AM. Both early voting locations will be open.

6. Qualifying

Director Gay advised that Qualifying for the May 21, 2024, General Primary and Nonpartisan General Election opens at 9:00 AM Monday March 4, 2024 and closes 12 Noon on Friday, March 8, 2024.

Positions open will be Sheriff, Clerk of Superior Court, Probate Judge, State Court Judge, Chief Magistrate Judge, Solicitor-General, Tax Commissioner, Coroner, Surveyor, County Commissioner District 1, County Commissioner District 4, County District 5, Board of Education District 2, Board of Education District 3, and Board of Education District 2 At Large.

Persons may qualify for the Primary by filing a Declaration of Candidacy and Affidavit and paying the qualifying fee to their party at the location designated by the party.

Republican Party - 14 Greenville Street Newnan, GA 30263

Democratic Party - 40 Greenway Court # D Newnan, GA 30265

The offices of State Court Judge and Solicitor General are scheduled for election in calendar year 2024, if the governor makes an appointment within 6 months of the scheduled election, said election will be canceled pursuant to law and the qualifying fees refunded.

7. Georgia Soil and Water Conservation Commission Agreement

Director Gay advised that the office received the agreement which details the responsibility of the Election Superintendent as specified by the Commission and Rule 600-9 from the Georgia Soil and Water Conservation Commission. Director Gay asked that the Board accept this agreement and sign it, so that it can be returned to the Georgia Soil and Water Conservation Commission. The agreement states that the Board agrees to conduct their elections and any run-offs. The Election would be in November 2024.
