Chairman Reeves called for any public comments.

Attorney Michael Hill advised the following rules for Public Comment

- Based upon the Rules Governing Regular Meetings that were approved earlier by the Board, a maximum of ten (10) speakers shall be allowed to address the Board. Each speaker must sign-up to speak prior to the start of the meeting. Speakers will be called on a first come basis and be allowed up to three (3) minutes each. Each speaker must state his or her name and address for the record.
- Each speaker will be respectfully heard by the Board without public display or approval or disapproval from the audience. The Board will not engage with the speaker during or after his or her comments. The Board will listen to any questions or comments and take them into consideration.
- While a speaker is allowed to make any comment he or she wishes, questions or concerns regarding elections equipment should be addressed to the State, not this Board.

Mr. Mike Nixon, 79 Lawn Market Sharpsburg. Nixon spoke on Election Integrity and an error known as the Williamson Error from Williamson County, Tennessee. He advised that he reviewed the slog files from 2022 and 2024. Nixon also spoke on new SEB rules.

Mr. Allen Brady, 59 Barrington Overlook Sharpsburg. Brady addressed the Board regarding a pending lawsuit. Brady also spoke on Voter Registration Numbers. Brady commended the Office and stated that they do not work for the SOS but work for the Citizens of Coweta County.
